1. Protecting Your Information

MAPFRE Insurance has always made it a priority to protect your personal and privileged information. We do not sell your information. We limit access to your personal and privileged information to those persons who need to know it to perform their jobs and to provide service to you, and as required or permitted by law. We maintain physical and electronic safeguards to protect such information from unauthorized use or disclosure.

You may have additional concerns about the privacy and security of information collected through our website. We are committed to protecting the online privacy of visitors to our website. We maintain physical, electronic, and procedural safeguards to secure your personal information. However, "perfect security" does not exist on the internet, and there is always some risk in transmitting information electronically. As we deem appropriate, we use security measures consistent with industry standards, such as firewalls and encryption technology, to protect your information.

Our website may contain links to other websites. We do not control privacy practices or content of any of our business partners, advertisers, sponsors, or other websites we provide links to from our website. You should check the applicable privacy policy of the website sponsor when linking to other websites.

We protect information of our former customers in the same way as for our current customers.

2. Accessibility

3. Categories of Personal Information We Collect

We collect personal information that we believe is necessary to serve you effectively and to permit us to meet your needs. Information we collect includes information that identifies, relates to, describes, references, is reasonably capable of being associated with, or could reasonably be linked, directly or indirectly, with you or your device. We also may collect personal information from insurance agents (if applicable) who may use our protected and secure Internet based portal to administer policies.

Age (40 years or older), race, color, ancestry, national origin, citizenship, religion or creed, marital status, medical condition, physical or mental disability, sex (including gender, gender identity, gender expression, pregnancy or childbirth and related medical conditions), sexual orientation, veteran or military status, genetic information (including familial genetic information).
D. Biometric Information.	Genetic, physiological, behavioral, and biological characteristics, or activity patterns used to extract a template or other identifier or identifying information, such as, fingerprints, face prints, and voiceprints, iris or retina scans, keystroke, gait, or other physical patterns, and sleep, health, exercise data.
E. Internet or other similar network activity.	Browsing history, search history, information on your interaction with a website, application, or advertisement; IP address; the website from which you visited us; the type of browser software used; the website pages that you visit, and the date and duration of your visit to our website; cookies (See "Cookies" section of this Privacy Notice for more detail); social media data.
F. Geolocation data.	Physical location or physical movement
G. Professional or employment-related information.	Current or past job history or performance evaluations.
H. Non-public education information.	Education records directly related to a student maintained by an educational institution or party acting on its behalf, such as grades, transcripts, class lists, student schedules, student identification codes, student financial information, or student disciplinary records.
I. Inferences drawn from other personal information.	Profile reflecting a person's preferences, characteristics, psychological trends, predispositions, behavior, attitudes, intelligence, abilities, and aptitudes

Categories of Information Sources

We obtain the categories of personal information listed above from several categories of sources.

- Directly from you, including from:
 - o your insurance application;
 - o correspondence and communications with you;
 - o information about your transactions with us;
 - information that you provide to us on our website;
- Indirectly from you, including from:
 - o observing your activity on our website;
 - your insurance agent or broker (if applicable);
 - website usage (or traffic);
 - o employee benefit vendors;
- Other Sources, including from:
 - o consumer reporting agencies;
 - o customer lists provided by other organizations and marketing data providers;
 - o governmental agencies and insurance-support organizations;
 - o insurance claims, which may include medical information;
 - o sources to administer employee related benefits and services;

4. Use of Personal Information

We may use or disclose personal information we obtain for one or more of the following purposes:

- To fulfill or satisfy the purpose for which you provided the information to us.
- To provide, support, personalize, and develop our website, products, and services.
- To create, maintain, customize, and secure your account with us.
- To process your requests, purchases, transactions, and payments and prevent transactional fraud.
- To provide you with support and to respond to your inquiries, including to investigate and address your concerns and monitor and improve our responses.
- To personalize your website experience.
- To deliver content, product, and service offerings relevant to your interests, including targeted offers and advertisements through our website, third-party sites, and via email or text message with your consent, where required by law
- To help maintain the safety, security, and integrity of our website, products and services, databases and other technology assets, and business.
- For testing, research, analysis, and product development, including to develop and improve our website, products, and services.
- To respond to law enforcement requests and as required by applicable law, court order, or governmental regulations.
- As described to you when collecting your personal information or as otherwise set forth in the CCPA.
- To evaluate or conduct a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of our assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which personal information held by us about our website users/consumers is among the assets transferred.
- To the extent that we collect protected classification information, we collect such information to comply with federal and state law and/or, to deliver employee benefits & services.
- To deliver employee related benefits & services for prospective, current, and past employees.

In addition, the information may also assist us with managing our business including but not limited to: maintaining business continuity plans, conducting internal audits, building actuarial and statistical models, and fulfilling various legal requirements, or to perform obligations under an existing contract with you.

We will not collect additional categories of personal information or use the personal information we collected for materially different, unrelated, or incompatible purposes without providing you notice.

5. Sharing Personal Information

We share information with the following categories of third parties:

Government, Regulatory, Law Enforcement, Legal Professionals

This category includes industry regulators, law enforcement agencies or other governmental authorities; attorneys or other authorized persons in connection with matters in litigation, as required by subpoenas and court rules and orders; anti-fraud organizations; our attorneys, accountants, and auditors; and such other parties as are specifically permitted or required by law.

Service Providers & Other Parties

This category includes third parties that assist us in processing transactions authorized by you and third parties that support our ability to provide services to you; third parties with which we have joint marketing agreements in order to market our products; and third parties that help us conduct research and analyze data to improve our products and services;

Employee Related Services

This category includes third parties that assist us to conduct various activities related to prospective, current and past employees including background checks, and administration of various employee and employee related services and benefits.

7. Sales of Personal Information

WE DO NOT SELL PERSONAL INFORMATION, INCLUDING THOSE OF MINORS UNDER THE AGE OF 16, TO EXTERNAL PARTIES.

8. Your Rights Under California Law

California law grants you specific rights regarding your personal information including the "Right To Know," "Right to Access," "Right to Deletion," "Right To Opt-Out," and "Right To Non-Discrimination". This section describes your rights and explains how you may exercise those rights.

Right To Know

You have the right to know of the categories of personal information we collect, and the purposes for which the categories of personal information are used. You also have a right to know of the categories of personal information that we have disclosed about you to another party for a business purpose.

Right to Access

You have the right to request that we disclose certain information to you about our collection and use of your personal information over the past 12 months. Once we receive and confirm a <u>Verifiable Consumer Request</u>, from you we will disclose to you:

- the categories of personal information we have collected about you,
- the categories of sources from which the personal information was collected,
- the business or commercial purpose(s) for collecting personal information,
- the categories of third parties with which we shared personal information, and
- the specific pieces of personal information we collected about you.

Right to Deletion (aka Right To Be Forgotten)

You have the right to request that we delete any of your personal information that we collected from you and retained, subject to certain exceptions. Once we receive and confirm a <u>Verifiable Consumer Request</u> from you, we will delete (and direct our service providers to delete) your personal information from our records, unless an exception applies.

Right To Opt Out

California law requires businesses that sell personal information to third parties to provide consumers with the right to opt-out of that business selling their personal information to third parties. We do not sell personal information to third parties.

9. Verifiable Consumer Requests

Only you, or someone legally authorized to act on your behalf, may make a verifiable consumer request related to your personal information. Upon receiving a request, we are required to verify your identity before granting your right to access or delete personal information about you. You may also submit a Verifiable Consumer Request on behalf of your minor child.

You may only submit a Verifiable Consumer Request for access or data portability twice within a 12-month period.

The Verifiable Consumer Request must:

- 1. Provide sufficient information that allows us to reasonably verify you are the person about whom we collected personal information or an authorized representative. We will verify your request by matching the information you provide to us with information we have about you. We will request the following information from you: Full Name, Mailing Address, and telephone number. You may but are not required to include Email, Policy Number (if applicable), and Claim Number (if applicable) with your Verifiable Consumer Request.
- 2. Describe your request with sufficient detail that allows us to properly understand, evaluate, and respond to your request.

WE CANNOT RESPOND TO YOUR REQUEST OR PROVIDE YOU WITH PERSONAL INFORMATION IF WE ARE UNABLE TO VERIFY YOUR IDENTITY OR AUTHORITY TO MAKE THE REQUEST AND CONFIRM THE PERSONAL INFORMATION RELATES TO YOU.

You are not required to create an account with us before submitting a Verifiable Consumer Request.

We will only use personal information provided in a Verifiable Consumer Request to verify the requestor's identity or authority to make the request.

We do not charge a fee to process or respond to Verifiable Consumer Requests unless it is excessive, repetitive, or manifestly unfounded. If we determine that a request warrants a fee, we will tell you why we made that decision and provide you with a cost estimate before completing your request.

If you wish to submit a request through an authorized agent, we may require the authorized agent to provide proof that you gave signed permission to submit the request. We may require:

- That you verify your identity with us; or
- That you provide us with direct confirmation that you authorize the agent to make the request

If your authorized agent has a valid power of attorney under California Probate Code sections 4000 to 4465, we may request proof of the power of attorney. We may deny a request from an agent that does not submit proof you authorized them to act on your behalf.

10. Non-Discrimination

We do not discriminate against you for exercising any of your CCPA rights. Unless otherwise permitted by California law, we will not:

- 1. Deny you goods or services for which you are eligible.
- 2. Charge you different prices or rates for goods or services, including through granting discounts or other benefits, or imposing penalties.
- 3. Provide you a different level or quality of goods or services.
- 4. Suggest that you may receive a different price or rate for goods or services or a different level or quality of goods or services.
- 5. However, we may offer you certain financial incentives permitted by the CCPA that **can result** in different prices, rates, or quality levels. Any CCPA-permitted financial incentive we offer will reasonably relate to your personal information's value and contain written terms that describe the program's material aspects. Participation in a financial incentive program requires your prior opt in consent, which you may revoke at any time. We do not currently provide any financial incentives to consumers.

11. Cookies

We use "cookies" to enhance your access to our website. A cookie is a small amount of data that is sent to your browser from a web server and stored on the hard drive of your computer or mobile communications device. We use cookies to store information and personalize your experience with our website. For example, cookies allow our website to recognize you as a previous visitor, and thus save and remember any preferences that may have been set while you were previously browsing our website. You do have some control over cookies. Many browsers can be set to notify you when a cookie is being placed on your computer. Many browsers can also be set to refuse to accept cookies, although this may affect your internet experience. You can also erase cookies that are already on your computer. For more information about working with cookies, you should consult your user manual, FAQ, or "help" function of your specific browser and operating system software.

We use cookies to perform statistical analysis, authenticate user sessions, and improve and customize our services by analyzing your browsing habits.

12. Do Not Track

Some browsers have "do not track" features that allow you to tell a website not to track you. These features are not all uniform. We do not currently respond to those signals. Instead, we collect, use, and share information as described in this Privacy Notice regardless of a "do not track" choice.



13. Other California Privacy Rights

California's "Shine the Light" law (Civil Code Section § 1798.83) permits users of our website who are California residents to request certain information regarding our disclosure of personal information to third parties for their direct marketing purposes.)
